If payment is not received in full at the end of the term of credit extended, interest will begin to accrue (Service Charge) on each separate transaction at a rate of 1.5% per month which is an Annual Rate of 18%. In addition, if invoices are not paid within 45 days of ship date, all prices will revert to highest published catalog price, and all agreed upon discounts and special pricing will become void.
